However David Lavin said that we could vote on the leasing right there and it passed unanimously! So I made the motions, some of which you were looking for to some degree to help get things done. None of this was mentioned.

I can send in my comments separately, or if you care to just mention what I have just said, I would leave it in your hands.

It must be incredibly frustrating for you to face disgruntled members who have legitimate questions, and to be able to offer them very few answers. Of course, you want to reassure them but for some time the Governor's questions and concerns have also gone unanswered. I have been away from chess for some time and as I try to uncover the mysteries of the CFC. I find that one question leads to two, which leads to four, which leads to an impenetrable morass of conflicting information, curious opinions, and well-intentioned mistakes.

The most valuable resource we can all offer to the CFC is our time and goodwill. I have limited time to devote to the CFC, and have decided that I will devote all of it to the future of the organization, rather than to unravelling the mysteries of past decisions. To that end, I can say that much has been accomplished since the AGM in Montreal. If I can ask you to be patient a little longer, I should have the business plan for the Governor's to review prior to the end of the August.

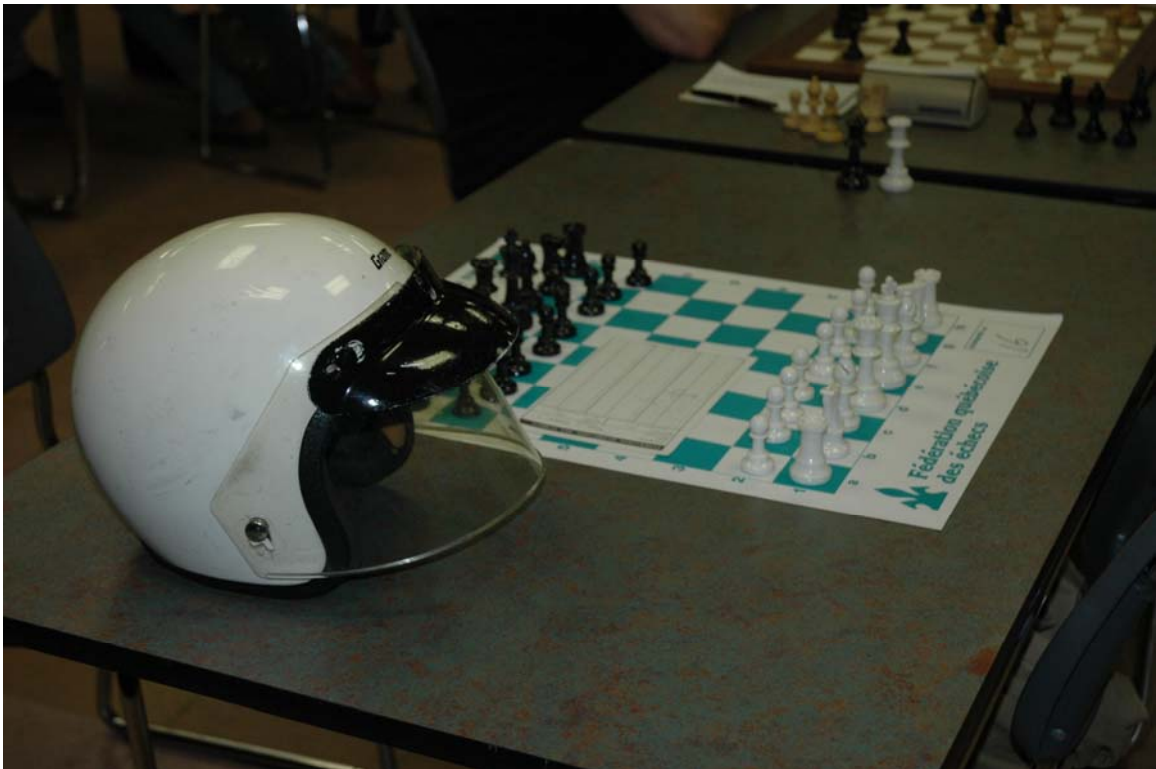



SCC'ers at the 2008 Canadian Open

(1st in a series of 3 articles)

The 2008 Canadian Open took place in Montreal, Quebec, from July 19 – 27. It was a 9 round swiss, in 5 sections, and 330 players were registered, including in the Open Section, 15 GM's.

8 stalwart SCC'ers went to try their skill and luck. They played in 3 different sections. Their results were, in 9 rounds:

Open Section:

40/48 – FM Yuanling Yuan – 3 pts. (1 pt. was a director's 1 pt. bye)

U 2400:

27/53 – Oscar Villalobos – 4.5 pts. (1st round ½ pt. bye due to T.D. error)

U 2000:

- # 8/77 – Bob Armstrong – 6.5 pts.
- # 12/77 – Alex Ferreira – 5.5 pts.
- # 13/77 – Tyler Longo – 5.5 pts.
- # 50/77 – Mario Moran-Venegas – 4 pts.
- # 58/77 – Uwe Hahnewald – 3.5 pts.
- # 60/77 – Michael Perez – 3 pts.

As usual, I begged, pleaded, threatened everyone to give me their “ most interesting “ game from the tournament – it didn’t necessarily have to be a win; a draw or loss was OK if it was interesting and instructive. I will publish the games I received over the next few Issues in this serial article.

Needless to say, I was pleased with my own result, and if I can, I’d like to start with one of my own wins. The game only lasted 27 moves. I developed a strong attack, offered a rook and knight sacrifice (rightly refused by my opponent – he finished # 14/77), and ended up with a mate threat. Here is the game (Annotations by Bob Armstrong, using Fritz):

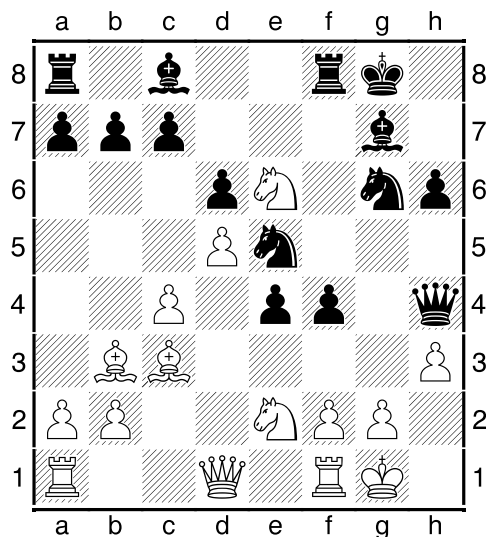

In the U 2400 section, Oscar Villalobos started off the tournament with a glitch. When Oscar registered for the CO, his rating was in the 1900's, and so he registered for the U 2000 section. But a good tournament at the BGC, which had been delayed in being rated for a while, got rated the Wednesday before the tournament started. It put Oscar

over 2000 for the first time. I told him that as far as I knew, the TD checked everyone's rating against the most recent rating list, and that he would then be moved into the U 2400 section. But when we got there and looked at the pairings, Oscar was still shown as in the U 2000 section. He went to see the TD about it, and was advised that it was then too late to change the pairings, and that in Rd. 1, he would be given a "bye" in the U 2400 section. But he would still play his paired game in the U 2000 section in Rd. 1, so that he and his opponent each had a game. Then he would be withdrawn from the U 2000 section.

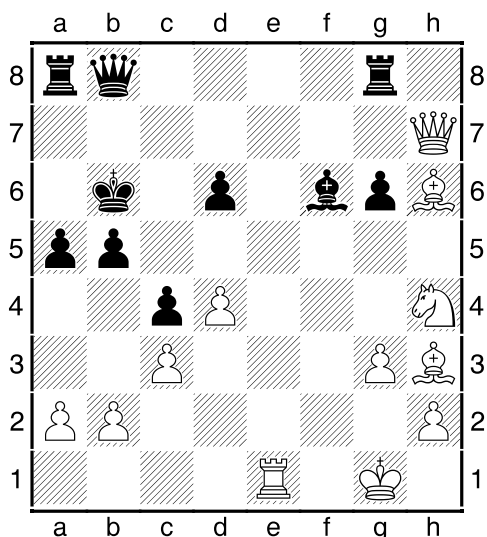

Cohen's Chess Movies' Reviews – The Chess Player

'The Chess Player' ('Le Joueur d'Échecs') is a 1927 silent film from France, with English titles. It is a fictional story of a real automaton called The Turk, which was invented by Baron von Kempelen. Using historical characters, including the Baron, and weaving in real incidents from The Turk's career, a fictional account of the creation of the Turk is told. The film is a love story, set against the sweep of historical events: a 1776 uprising of Polish Lithuania against Russian occupation. The director filmed in Poland, and tried to be as historically accurate as possible in the details, from the protocols of royalty to the movements of The Turk.

The film is suitable for all ages, however, parental guidance is needed to explain the actions of the occupying Russian army. DVD extras include a radio interview with Tom Standage, author of 'The Turk: The Life and Times of the Famous Eighteenth-Century Chess-Playing Machine' (2002), in which he reveals the real life motivation for the invention; and a PDF file with the transcript of an interview with the film's director, 40 years after he made the film.

You can rent the DVD in Toronto at Queen Street Video, 480 Bloor St. W.; call ahead at (416) 588-5767 to ensure that it is in and to reserve it. Do not mix it up with 'The Chess Players', a film from India (reviewed in Volume 7, No. 18, 2006.05.15) which you may want to rent at the same time!

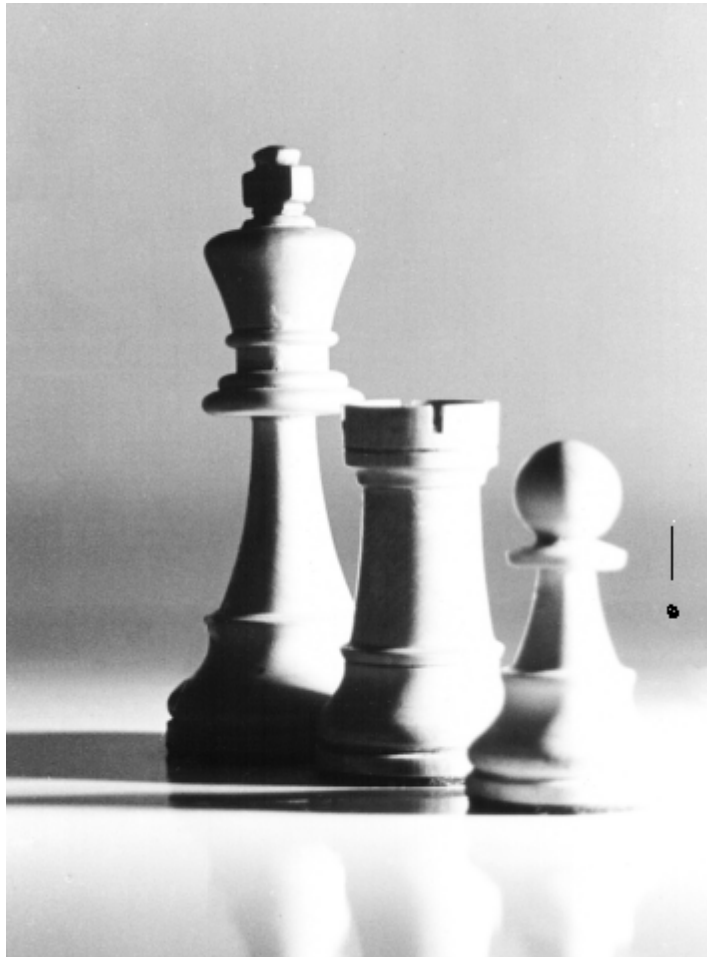
